

CNY21 TURNAROUND PROSPERITY PACK CONTEST

CONTEST RULES & REGULATION

The Organiser & Contest Period

1. The CNY21 TURNAROUND PROSPERITY PACK CONTEST (“Contest”) is organised by F&N Beverages Marketing Sdn. Bhd. (“Organiser”).
2. The Contest is open to all residents of Malaysia aged 18 and above as of 07/12/2020 except the Organiser’s affiliates, subsidiaries, advertising/PR agencies and suppliers. Qualifying Criteria & Submission of Entry

5. Every purchase of the 100PLUS TURNAROUND FORTUNE PROSPERITY PACK worth RM88 (“Product”) on the F&N Life website www.fnlife.com.my will automatically entitle you to enter the Contest. The Product is available while stocks last only.
6. For every purchase of 1 (one) Product you will be entitled to 1 (one) entry submission.
7. Each Participant is entitled/eligible to purchase more than 1 (one) Product.
8. All entries received are subject to the Organiser’s verification. Weekly Prize

14. The serial numbers allocated to the weekly Qualified Entries will be tabulated which will then be divided by 12 (twelve) to derive the weekly winning serial numbers for the Weekly Prizes. In the event

of numbers with decimal values, the winning serial numbers will be rounded down to the nearest whole number that results after the division.

For example: If the weekly Qualified Entries serial numbers for Week 1 total up to 289, 289 will be divided by 12 which equal 24.08 which will be rounded down to 24. The multiplier winning serial number in this case is 24. 12 (Twelve) Qualified Entries assigned with serial numbers with multiples of 24 i.e. 24, 48, 72, 96, 120, 144, 168, 192 and so forth will be the selected finalists of the Weekly Prizes.
